BETWEEN:

THE RURAL MUNICIPALITY OF SNIPE LAKE NO. 259, a municipal corporation of and in the Province of Saskatchewan, hereinafter referred to as "Snipe the party of the first part

- and -

THE TOWN OF ESTON, a corporate body under the authority of The Town Act, of the Province of Saskatchewan, hereinafter referred to as "Eston" the party of the second part

WHEREAS the parties desire to associate with each other for the purpose of establish and operating a regional park pursuant to the provisions of The Regional Parks Act, 1960, being Chapter 40 of The Statutes of Saskatchewan of 1960, and hereinafter call the "Act" upon the area commonly referred to as the Eston Riverside Pool and Playgro and to be known in the future as the Eston Riverside Regional Park.

NOW THEREFORE THIS AGREEMENT WITNESSETH that in consideration of these presents and the covenants, promises and agreements hereinafter contained, the parties hereto joi and severally agree as follows:

- 1. The parties agree to associate and work together to elect a Regional P Authority and to create a regional park in accordance with the provisions of The Regional Parks Act and Regulations.
- 2. To maintain and operate as a regional park until a Regional Park Authoris appointed by the parties and constituted under the Act, all that parcel of land commonly referred to as Fr. No 17-23-20-3 and more particularly described as follows That Part of Section 17-23-20-3 north of the South Saskatchewan River.
- 2A. The parties hereto agree that not less than two thirds of the director appointed in any year to operate the affairs of the Regional Park Authority shall be share-holders of the Eston Riverside Pool and Playground Limited.
- 2B. The parties hereto agree that the term of office of the Directors of t authority shall commence January 1st in the year of appointment, except in case of casual vacancy or other vacancy the term shall commence on date of appointment for unexpired term of the director replaced. The term of office shall be for a three ye term except for the directors appointed for the years 1962 and 1963 in which case th directors shall hold office for one year and three directors shall hold office for t years. The parties hereto further agree and do hereby appoint the following to the Board of Directors:-
- W. E. Rooke, J. G. Shea and Earle Clarke for a one year term commencing January 1st, Harry Eichel, Walter Gross and Dr. L.N.Kjorven for a two year term commencing Januar 1st, 1962. A. H. Kraft, J. B. Martin, A. F. R. Rooke and W. A. Irvine for a three y term commencing January 1st, 1962.
- 3. Each party agrees to make annual grants under Section 10 of the Act in order to share all costs to be borne by parties of acquisition, development, operati and maintenance up to a maximum total of Eight Hundred Dollars (\$800.00) in any one year over a period of five years from the date hereof of the Regional Park created upon the said lands in the following proportions:

R. M. of Snipe Lake No. 259 - annual cost \$400.00 Town of Eston - annual cost \$400.00

- 4. Each party agrees to designate one representative to act with the othe representatives named by the parties in order to conduct preliminary negotiations and the preparation of plans for the regional park and to prepare a submission for assistance under Section 6 of the Act;
- 5. The parties agree to perform and do all acts necessary in order to rat and confirm this agreement and in particular the parties agree to pass a complementa bylaw authorizing the execution and performance of this agreement;
- 6. The parties agree that this agreement shall not take effect unless and until the same has been duly approved by the Local Government Board;
- 7. The parties agree that there shall be no liability arising from this a ment for the cost of operating or maintaining the regional park after five (5) years from the date first above written.

8. This agreement shall be renewable at the end of five years should the municipalities participating under this agreement so desire.
