BYLAW #05-2014

A BYLAW FOR THE PURPOSE OF GIVING APPROVAL TO AN AGREEMENT TO ESTABLISH AND OPERATE A REGIONAL PARK UNDER THE PROVISIONS OF THE REGIONAL PARKS ACT, 1960

The Council of the R.M. of Snipe Lake No. 259, in the Province of Saskatchewan, enacts as follows:

That the agreement hereunto attached and identified as "Schedule A" of this Bylaw is hereby ratified and approved and the Reeve and Administrator are hereby authorized to execute the same on behalf of the Rural Municipality of Snipe Lake No. 259 and to affix the corporate seal of the Municipality.

THIS AGREEMENT made this _____ day of _____, 2013

BETWEEN:

THE RURAL MUNICIPALITY OF LACADENA #228
a municipal corporation of and in the Province of Saskatchewan,
hereinafter referred to as "R.M. of Lacadena"
the party of the first part

- and -

THE RURAL MUNICIPALITY OF MONET #257
a municipal corporation of and in the Province of Saskatchewan,
hereinafter referred to as "R.M. of Monet"
the party of the second part

- and -

THE RURAL MUNICIPALITY OF VICTORY #226
a municipal corporation of and in the Province of Saskatchewan,
hereinafter referred to as "R.M. of Victory"
the party of the third part

- and -

THE RURAL MUNICIPALITY OF SNIPE LAKE # 259
a municipal corporation of and in the Province of Saskatchewan,
hereinafter referred to as "R.M. of Snipe Lake"
the party of the fourth part

- and -

THE TOWN OF ELROSE
a municipal corporation of and in the Province of Saskatchewan,
hereinafter referred to as "Elrose"
the party of the fifth part

- and -

THE TOWN OF KYLE
a municipal corporation of and in the Province of Saskatchewan,
hereinafter referred to as "Kyle"
the party of the sixth part

- and -

THE VILLAGE OF BEECHY
a municipal corporation of and in the Province of Saskatchewan,

R.M. OF SNIPE LAKE NO. 259

hereinafter referred to as "Beechy"

the party of the seventh part

WHEREAS the parties named above desire to continue to associate with each other for the purpose of further developing and operating the regional park known as CLEARWATER LAKE REGIONAL PARK, established under *The Regional Parks Act*.

NOW THEREFORE THIS AGREEMENT WITNESSETH that in consideration of these presents and the covenants, promises and agreements hereinafter contained, the parties jointly and severally agree as follows:

1. To continue to associate and work together.
2. To appoint one (1) representative per municipality to CLEARWATER LAKE REGIONAL PARK.
3. To continue to develop, operate and maintain that area of land now designated as CLEARWATER LAKE REGIONAL PARK and more particularly described as follows:
 Fraction of Section 18, in Township 22; Range 14; West of the 3rd Meridian, in the Province of Saskatchewan.
4. The parties agree that there shall be no liability arising from this agreement for the cost of operating or maintaining the park.
5. The parties agree to perform and do all acts necessary in order to ratify and confirm this agreement and in particular the parties agree to pass a complementary bylaw authorizing the execution and performance of this agreement.
6. This agreement may be continuous with review by the municipalities at the end of one (1) year should the municipalities participating under this agreement so desire.
7. Bylaw No. 07-2013 is hereby repealed.

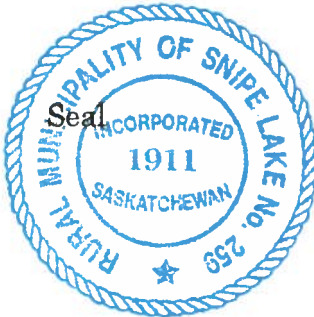
