### WATERWORKS RATE POLICY

The Town Council in Eston reviews rates annually at budget time

The objective is to ensure the Town of Eston is covering costs and put money in reserves for future capital costs.

### WATERWORKS CAPITAL INVESTMENT STRATEGY

To cover the costs of future waterworks infrastructure maintenance and replacement, Council will analyze revenues and expenses of utilities and will adjust rates as necessary to build the waterworks capital reserves. The capital investment strategy will ensure that safe drinking water can continue to be provided to the residents, businesses, and surrounding rural community in the future.

Asset Management plans for both Water and Sewer are to plan for replacement and repairs of water and sewer infrastructure. Future infrastructure upgrades will continue, such as sewer lining and lift stations.

## **ANNUAL WATERWORKS FINANCIAL OVERVIEW**
